EXECUTIVE SUMMARY

Appointments to the UBC Foundation Board have traditionally been made through a Provincial Order in Council, as per the terms of the University Foundations Act. In late 2003 Bill 35 received Royal Assent which among other things amended the University Foundations Act to allow board member to be appointed directly by the University's Board of Governors. The University Foundations Act further stipulates that the Foundation shall consist of five members; two from the UBC Board of Governors and three from the public at large. Current members are: Douglas Mitchell from the UBC Board of Governors and Clark Warren, Michael Bentley and Dale Parker from the public at large.

This is Mrs. Bennett's initial term as Member.

The UBC Foundation requires a Chair and a quorum of three in order to hold board meetings and conduct its business.
