Paul Carter

Professor of Teaching, Computer Science Faculty of Science

Killam Teaching Prize, 2013-14

Dr. Paul Carter graduated from the University of Sheffield with a Bachelor of Science (Honours) and subsequently completed a Master of Science at UBC, graduating in 1988. He later went on to earn a PhD from UBC in 1993. He has since served in teaching roles at Capilano College and UBC, receiving the Computer Science Department's teaching award in 2004, 2008, 2009 and 2012. He became a Professor of Teaching in 2013.

Dr. Carter is particularly interested in the use of technology in education, and has been involved in the development of web-based materials that not only present learners with raw information but also present an opportunity to learn in an interactive manner through the use of multimedia.

Dr. Carter directed UBC's new Bachelor of Computer Science (Integrated Computer Science) Program during its first two years in operation. He is currently part of the "Flipped Lab" Network, a faculty-led collaboration which will provide community support to discuss and develop effective, engaging flipped classroom approaches across UBC.

2014 Killam Fellowship Canada Council for the Arts

Congratulations to Dr. Stephen Withers who has been awarded a prestigious Killam Fellowship from the Canada Council for the Arts. The honour recognizes Dr. Withers' contributions to our understanding of the reaction mechanism of enzymes.

Dr. Withers is a world leader in the emerging field of engineering carbohydrate-modifying enzymes. He proposes a creative and original approach in his project, *Development and use of ultra-high-throughput screens for directed evolution and metagenomics*. He will go beyond the engineering of known enzymes and develop techniques that will enable the discovery of unknown enzymes for their subsequent modification. The impact of his work extends across many disciplines. His research has opened new doors for treating various diseases and introduced new research techniques. Among his achievements is an inhibitor with the potential to prevent the influenza virus from using its own enzymes to spread through the body. Improved treatments for diabetes and other diseases are also possible as well as new ways to synthesize complex sugars using engineered enzymes.

Dr. Withers completed his BSc and PhD at the University of Bristol and postdoctoral work at the University of Alberta and has been at UBC since 1982. In 2012, he was elected a Fellow of the Royal Society of London.

Dr. Peter Zed completed Bachelors of Science in Chemistry (Dalhousie) and Pharmacy (Memorial), and a Doctor of Pharmacy at the University of British Columbia in 1998. He then accepted the position of Pharmacotherapeutic Specialist, Emergency Medicine, at Vancouver General Hospital. He also served the UBC Faculty of Pharmaceutical Sciences as a Clinical Assistant Professor and then Clinical Associate Professor in the years 1998-2006, returning to UBC in 2011 as Associate Professor and Associate Dean for Practice Innovation. In the intervening years (2006-2011) Dr. Zed moved to Halifax to serve as Clinical Coordinator, Department of Pharmacy, and Pharmacotherapeutic Specialist, Emergency Medicine, for Queen Elizabeth II Health Sciences; and was Associate Professor in the College of Pharmacy and the Department of Emergency Medicine, Faculty of Medicine at Dalhousie University.

Dr. Zed has sustained a productive research program, publishing over 80 peer-reviewed papers and over 100 conference research abstracts. He has also recently been awarded the Top Pediatric Abstract Award at the Canadian Association of Emergency Physicians Annual Scientific Meeting. He has taught extensively to both undergraduate and graduate students as well as other health care professionals. He has won numerous awards including the Jessie I. MacKnight Award for Excellence in Teaching at Dalhousie University (a two-time recipient) and Preceptor of the Year Award for the UBC PharmD Program. This is his eighth National award from the Canadian Society of Hospital Pharmacists.
